In the presence of the members singed above, the proceeding of the meeting is started by the instruction of the Chairperson, Board of Administrators and Operation & Maintenance of Garment Hub and Karmatirtha Committee, Beldanga Municipality. The following decisions are taken unanimously:-

Garment Hub

1. The previous resolutions on 16.07.2021 are read and confirmed by all present.
2. Existing Vacant ground floor Stalls of Garment Hub including those reserved for the municipality will be distributed among the recognized Old Garment Market traders as privilege category on their demand on priority basis in order to invite more and more enterprises making the hub more popular.
Action :- (i) Partha Sarathi Ghosh, S.A.E & Nodal Officer, (ii) Somnath Mondal, Store Keeper.
3. Existing vacant stalls of any floor except ground will be redistributed among the existing leaseholders intending to take a shift, only after realization of the prerequisite balance caution (security) money deposit applicable to the particular floor on priority basis.

4. The business transactions timing of the Garment Hub (SAJBITAN) operated by the Municipality is now rescheduled from 3:00 PM to 10 PM on every Thursday.

5. The Garment Hub leaseholder of stall no. 2/G/9 is hereby allowed to remain in his previous stall only after realization of the caution (security) money deposit as returned to him earlier based on his prayer now intending to retain the stall.

Karmatirtha

6. 'Karmatirtha' Shops can now be opened for any legal business and the vacant shops including those reserved for the municipality will be distributed by lottery system at the earliest.

7. The monthly rent of Karmatirtha shops is now revised as Rs. 600/- (six hundred) for ground floor and Rs. 400/- (four hundred) for 1st floor w.e.f 1st September, 2021

8. The monthly wage for the sweeper of Garment Hub and Karmatirtha, is also revised to Rs. 6500/- (six thousand and five hundred) w.e.f 1st September, 2021

9. It is also decided to fix a new gate in the middle of the wall in front of the medicine shop at 'Karmatirtha' shop no. 1.
