

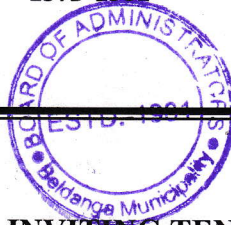

NOTICE INVITING TENDER

- 2) In case of bandh, holiday etc. falls on the schedule date as per enumerated above, the same may treated just after the next working day.
- 3) The earnest money shall be converted as part of security, the balance S.D. will be deducted from each progressive bill to have the S.D. amount of 10%.
- 4) If any Tenderer withdraw his Tender before its acceptance or refusal within 90 (ninety) days from the date of opening of Tender, without giving any satisfactory reasons, he shall be disqualified for submitting any Tender to the deptt. for a minimum period of one year. The corresponding earnest money will also be forfeited.
- 5) Contractor shall presume to have inspected the site of work before submission of tender.
- 6) Conditional Tender will be nullified by the tender accepting authority.
- 7) All corrections in the Tender are to be signed and dated by contractors. Illegible, irregular, incomplete Tenders are liable to rejection.
- 8) Intending Tenderer must declare if there are any other firm or firms having common or identical interest with them.

- 9) The intending Tenderer(s) may see Tender documents and other relevant particulars (if any) during office hours in the office of the under signed. Application (in duplicate) along with valid up to date certificate of GST Registration, Current GST return, P. Tax Challan, Valid Trade License, and PAN Card, failing which no Tender paper will issued. Intending Tenderer(s) shall apply and obtain Tender papers in advance to guard against any difficulties due possible absence from the head quarters of the concerned officer. The application along with aforesaid papers will be referred to the appropriate authority of Beldanga Municipality for his examination and recommendation, on the basis of which Tender will be issued. **Earnest money to be deposited in form of Bank Draft/ Pay Order only from any Nationalized Bank and to be drawn in favour of the Chairperson, Beldanga Municipality.**
- 10) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned below:
- Full security deposit shall be refunded to the contractor on expiry of one year from the actual date of completion of the work.
- 11) The undersigned reserves the right to reject the lowest Tender or all the Tender without assigning any reason thereof.

N.B. Recovery of 1% (one percent) Cess on Gross bills to be made as per Regulation of Employment & Conditions Service Act. 1996.

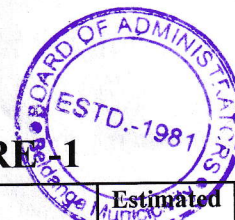
