2. **Credential**
  - a) Bonafied resourceful agencies having experience of execution of similar type of work/supply in-Govt/Semi-Govt./Autonomous Organization and with a Valid Payment Certificate or Credential in last 5(five) Years, No Private Credentials will be considered ,satisfactory completion certificate of work / supply completed during last 5 Financial Year must have to produce while Participating in the tender.
  - b) Intending Bidders must be financially sound and have their machineries required for the job.
3. Payment will be made through Account payee cheque or online.
4. Tax will be deducted as per running rule.
5. The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of

the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect.
