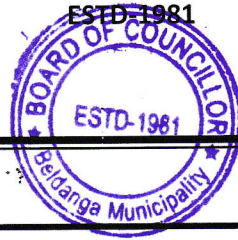

TERMS AND CONDITION ARE AS UNDER

1. The agency who agreed to participate in the quotation, will have to submit their rate in their letter head along with valid up to date certificate of Valid Trade License, PAN Card and credentials.
2. **Credential**
 - a) Bonafied resourceful agencies having experience of execution of similar type of work/supply in-Govt/Semi-Govt./Autonomous Organization and with a Valid Payment Certificate or Credential in last 5(five) Years, No Private Credentials will be considered ,satisfactory completion certificate of work / supply completed during last 5 Financial Year must have to produce while Participating in the tender.
 - b) Intending Bidders must be financially sound and have their machineries required for the job.
3. Payment will be made through Account payee cheque or online.
4. Tax will be deducted as per running rule.
5. The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the



work as mentioned below:

- Full security deposit shall be refunded to the contractor on expiry of one year from the actual date of completion of the work.
6. Supplied item will be rejected if it is not as per specification or bellow standard.
7. The entire work must be completed within 30 days from the received of the work order.
8. The Board of Councillors reserves the right to accept or reject any quotation without assigning any reasons whatsoever.
9. Other terms and condition will be followed as per rule.
10. Quotation will be received upto 1-30 PM on 15.02.2023 and opening will be done at 2-30 PM on 15.02.2023
11. The agency or their representative may remain present at time of opening.
