- 1) In the event of e-filling, intending bidder may download the tender documents from the website <https://tenders.wb.gov.in/nicgep/app> directly with the help of Digital Signature Certificate. The cost of tender document and the EMD as specified should be deposited through Draft and RTGS/NEFT in case of offline payment through bank Cheque in any Bank as per order of Finance Department Govt. of W.B. vide memo no. 3975-F(Y) dated 28.07.2016. The tenderer will have to submit their bid on-line in two cover/folder system containing prequalification document (Technical Bid) in one and Financial Bid in another. The list of important dates is also given in this Notice and Standard Bidding Document (SBD).

- 2) Cost of Tender Papers should be deposited by Cheque at Beldanga Municipality Office upto 05.00 p.m. on 26/12/2025 and Earnest money should be deposited at Beldanga Municipality office exclusively in the form of Nationalized Bank Draft in favour of The Chairperson, Beldanga Municipality, payable at Bandhan Bank, Beldanga Branch only. The NIeT No., and Serial No. should be clearly mentioned on the reverse side of the Draft, otherwise will be rejected.
- 3) Both Technical Bid and Financial Bid are to be submitted consecutively duly digitally signed in website <https://tenders.wb.gov.in/nicgep/app>.
- 4) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in Table – 2 of this tender notice.
- 5) The FINANCIAL OFFER of the prospective tenderer will be considered only if the TECHNICAL BID of the tenderer is found qualified by the Tender Evaluation Committee. The decision of this committee will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

**6) Eligibility criteria for participation in the tender.**

**i. Credential**

Intending tenderers should produce credentials of similar nature as a prime agency under authority of State / Central Government, State / Central Government undertaking / Statutory Bodies Constituted under the Statute of the Central / State Government as mentioned below:-

- A. For a completed work of the minimum value of 40% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice; or,
- B. For 2 (two) similar nature as mentioned above of completed work, each of the minimum value of 30% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice; or,
- C. For one single running work of similar nature as mentioned above which has been completed to the extent of 80% or more and value of which is not less than the desired value at (A) above;

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer.

**ii. Documents to be produced in support of Credential**

A successful performance and completion certificate supplemented with work order along with payment certificate issued by the competent authority shall have to be furnished in support of credibility in terms with eligibility criteria depicted in this Notice. Besides this, following documents shall have to be furnished:

- a. Particulars of ownership/ partnership or Board of Directors pertaining to the Organization/ Company/ Firm.
- b. Bank Solvency Certificate not less than 40% of estimated amount put to tender for each work not more than 12 months prior to the date of publication of this tender.
- c. Valid documents in support of annual Turnover.
- d. Audit report and Balance sheet authenticated by charter accountant in last five years.
- e. Experience and address, fax & telephone nos. , mobile no., & E-mail ID nos. of the firm.
- f. All documents in original to be produced in due course of time as & when asked by the TIA.

*[Non-statutory documents]*

- iii. Intending tenderers should produce turnover in a single year during last 3 (three) years of at least 40% (Forty percent) of estimated amount put to tender for which bid is submitted.

*[Non-statutory documents]*

- iv. Income Tax Acknowledgement Receipt for last assessment year, Current P. Tax Challlan, Pan Card, GST Registration Certificate, Current GST return, 26AS of I.T. Deptt. for last 5 F.Y. are to be accompanied with the Technical Bid Documents.

- v. In case of Partnership firm Registration Certificate from Registrar of Assurance shall have to submit. In case of Company certificate of incorporation is required.

[Non-statutory documents]

- vi. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. An affidavit in this respect has to be furnished by the prospective bidders without which the Technical Bid shall be treated as non-responsive.

[Non-statutory documents]

- vii. Registered Partnership Deed for Partnership Firm only along with Power of Attorney is to be submitted along with the application. In case of company shall furnish the Article of Association and Memorandum.

[Non-statutory documents]

- viii. A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all their bids will be rejected without assigning any reason thereof.

[Non-statutory documents]

- ix. Joints Venture will not be allowed.

- x. If any Bidder wants to apply in more than one works (Sl. No. 1, 2, 3.....etc. of Table – 1), his eligibility criteria for those works will be assessed in a cumulative manner for each individual aspect like Credentials, Bank Solvency, Annual Turn-Over etc. If after assessment, the bidder is found to be eligible for lesser works than what the bidder has applied for, the Tender Evaluation Committee will be the sole authority to decide for which work/works the bidder's eligibility has been considered. The Tender Evaluation Committee will not be liable to hear any requests from any third party or the bidder to make his decision.

- xi. Only works of nature depicted above completed successfully will be treated as credential. The bidder has no adverse report, on any account, against their organization for any project worked during last 5 (five) years or working at present. This clause will lead for rejection of application, even after fulfillment of other eligibility criteria. In this connection a declaration may be given as affidavit in non-judicial stamp paper. However, the tender inviting authority reserves the right to relax the eligibility criteria if felt necessary for the interest of fair competition.

- xii. Running payment for work may be allowed with the approval of appropriate Authority subject to a running account bill may be raised not less than 30% of the tender amount.

- xiii. No mobilization advance and secured advance will be allowed.

**xiv. Security Deposit :**

- a) Security Deposit towards performance Security amounting to 8% of the value of the work shall be deducted from the running account bill of the tenderer. No interest will be paid on Security Deposit. Earnest money @2% of the estimated value put to tender to be deposited at the time of tender which would be converted to Security Deposit in case of successful bidder.

- b) Additional Performance Security other than Security Deposit :

Additional Performance Security: As per Memo no.4608-F(Y) Dated 18.07.2018 of Finance Department Govt. of West Bengal, to ensure the quality and proper execution of the work in public interest, an

Additional Performance Security @ 10% of the Tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimate Put to tender.

The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank Before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within 7 (Seven) Working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other Necessary actions as per e-NIT like blacklisting of the contractor, etc., may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.

The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the Pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding Deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in No way be altered/ affected by provision of this Additional Performance Security.

- xv. Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
- xvi. Intending tenderer must have already recruited a technical personal for civil works who should have technical education minimum a Diploma in Civil Engineering or above. Necessary document such as
  - 1) Appointment Letter of Technical Personal.
  - 2) Salary Statement.
  - 3) Pass out Certificate should be enclosed.
- xvii. All materials required for the proposed work including cement, steel, bitumen, etc. shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufactured accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement, steel, bitumen are to be submitted along with challan and test certificate. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory or Government Engineering College shall have to be conducted by the agency at their own cost.
- xviii. Constructional Labour Welfare CESS @ 1% (one percent) of cost of construction will be deducted from every Bill of the selected agency along with all other statutory deduction as per time to time Govt. Laws towards Income Tax, GST, Royalties, etc.
- xix. There shall be no provision of Arbitration.**
- xx. Bid shall remain valid for a period not less than 180 (One Hundred Eighty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof

Note :

In case office faces sudden closure owing to reason beyond the scope and control of "The Chairperson, Beldanga Municipality", any of last date/dates as schedule in "Table-2" may be extended up-to/to next and following working day without issuing further and separate notice should the "The Chairperson, Beldanga Municipality", feels it to be necessary and exigent.

- 7) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 3 (three) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned below:
- (i) 30% of the security deposit shall be refunded to the contractor on expiry of one year after the issuance of certificate of completion of work;
  - (ii) Further 30% of the security deposit shall be refunded to the contractor on expiry of two years.
  - (iii) The balance 40% of the S.D. shall be refunded to the contractor on expiry of three years.
- 8) Execution of the Work: The Contractor is liable to execute the whole work as per direction and instruction of the Engineer in Charge of the work under this Municipality."
- 9) **Employees Provident Fund:** The intending bidders shall have to comply with the followings and to be submitted its related documents: -
- i. Number of Employees :- a) Any establishment employing 20 or more persons is required to register under the EPF Act. b) In some cases, organizations with fewer than 20 employees can also opt for

voluntary registration.

- ii. Covered Establishments :- The Act applies to various industries, including factories, shops and other specified establishments.
- iii. Eligibility of Employees:- a) Any employee earning up to Rs. 15,000 per month (basic + dearness allowance) must be compulsorily enrolled in the EPF scheme. b) Employees earning above Rs. 15,000 can opt out, but only if they are not already EPF members from a previous job.

10) The intending Bidders should clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority Beldanga Municipality reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

11) Taxes & duties to be borne by the Contractor

Income Tax, GST, Royalty, Construction Workers' Welfare Cess and similar other statutory levy/ cess will have to be borne by the contractor and the rate should be quoted accordingly after consideration of all these charges.

12) Site inspection before submission of tender

Before submitting any tender, the intending tenderers should make themselves acquainted thoroughly with the local conditions prevailing at site by actual inspection of the site and taking into consideration all factors and difficulties likely to be involved in the execution of work in all respect including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local labour and market rate prevailing in the locality etc. and no claim, whatever, will be entertained on these account afterwards. In this connection intending tenderers may contact the office of Beldanga Municipal Authority, between 11.30 hours to 16.30 hours on any working day prior to date of submission of tenders.

13) Conditional and incomplete tender

Conditional and incomplete tenders are liable to summary rejection.

14) Refund of EMD:

- a. After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-Procurement portal of the State Government, the tender inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
- b. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date of which information on rejection of bid is uploaded to the e- Procurement portal by the tender inviting authority.
- c. Once the financial bid evaluation is electronically processed in the e-Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the tender

inviting authority. However, the L2 bidder should not be rejected till the LOI process is successful.

- d. If the L1 bidder accepts the LOI and the same is processed electronically in the e- Procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
- 15) Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in '**Instructions to Bidders**' stated in before tendering the bids.
- 16) The intending tenderers are required to quote the rate *ONLINE*.
- 18) Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act'1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 19) **Supplementary/Additional Items of Works:**  
Notwithstanding the provisions made in the related printed tender form, any item of work which can legitimately be considered as not stipulated in the specific priced schedule of probable items of work but has become necessary as a reasonable contingent item during actual execution of work will have to be done by the Contractor, if so directed by the Engineer-in-Charge and the rates will be fixed in the manner as stated below:-
  - (a) Rate of Supplementary items shall be analyzed in the 1st instant extended possible from the rates of the allied items of work appearing in the tender schedule of rates at the time of preparing of estimates.
  - (b) Rate of supplementary items shall be analyses to the maximum extent possible from rates of the allied items of work appearing in the schedule of rates of probable items of work as will be in force at the time of preparing estimate of the work of this NIeT.
  - (c) If the rates of the supplementary items cannot be computed even after application of clauses stated above, the same shall be determined by analysis from market rates of material, Labour and carriage cost prevailing at the time of execution of such items of work. Profit and overhead charges (both together) @10% (ten percent) will be allowed only. The contractual percentage will not be applicable.
  - (d) Black market rates shall never be allowed.
  - (e) It may be noted that the cases of supplementary items of claim shall not be entertained unless supported by entries in the Site Order Book or any written order from the tender accepting authority.
- 20) Guiding Schedule of Rates: Rates have been taken from P.W.D. (W.B.) Schedule of Rates for "Road & Bridge Works, Building Works, S & P works, Electrical Works" prevailing at the time of preparing estimates for the above works.
- 21) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited.
- 22) The Chairperson, Beldanga Municipality, reserves the right to cancel the NIeT due to unavoidable

circumstances and no claim in this respect will be entertained.

- 23) If there be any objection regarding prequalifying the Agency that should be lodged off line to the Chairperson, Beldanga Municipality within 2(two) days from the date of publication of list of qualified agencies and beyond that time schedule objection will not be entertained by the Tender Evaluation Committee.
- 24) 26 AS (TDS), I. Tax Acknowledgement Receipt, Bank Solvency, Credential, EPF, Technical Personal, Turn Over, are not mandatory for the works valued below 1 lakh.
- 25) The Tender Evaluation Committee reserves the right to relax the eligibility criteria if felt necessary in the time of Technical Evaluation for the interest of fair competition and speedy implementation of work valued below 5 lakh.
- 26) The Tender Evaluation Committee reserves the right to ignore minor deficiencies at their discretion in case of first call and no challenge whatsoever against such decision of the said committee will be entertained. In case of re tender, the Tender Evaluation Committee reserves the right to ignore some deficiencies at their discretion and no challenge whatsoever against such decision of the said committee will be entertained. In case of third and subsequent calls, the Tender Evaluation Committee reserves the right to ignore some more deficiencies at their discretion and no challenge whatsoever against such decision of the said committee will be entertained.
- 27) Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
- 28) If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence:
  - i. Tender Form No 2911
  - ii. NIeT
  - iii. All Corrigendum and Addendum, if any
  - iv. Technical Bid
  - v. Financial Bid
- 29) The tender inviting and Accepting Authority will determine the eligibility of each bidder. The eligibility of a bidder will be ascertained on the basis of the documents(s) submitted in support of the minimum criteria as mentioned in tender notice. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/ tenderer will be rejected at any stage without any prejudice.
- 30) Bidders should upload their documents from original copies. Uploading Photocopy & illegible copies will not be accepted.
- 31) This NIeT shall form a part of the contract document. The successful bidder on acceptance of his bid by the Accepting Authority, shall have to sign the contract consisting of NIeT, all tender documents forming part of the bid as uploaded at the time of invitation of bid, the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto and standard West Bengal Form No. 2911.
- 32) All G.O. issued by the Finance Department, Government of West Bengal and/PW Department, Government of West Bengal, related to e-Tender prior to the date of invitation is wholly, solely and squarely applicable.

- 33) Price Escalation: Adjustment of price (increase or decrease) vide Memo No.23-CRC/2M-61/2008 Dated 13.03.2009 & Memo No. 38-CRC/2M-61/2008 Dated 20.04.2009 shall not be applicable. Since BOQ for the works under this NIEt is based upon the schedule of rates of Public Works Directorate, Government of West Bengal with Addendum & Corrigendum as mentioned hereinafter, the bidders shall quote their rate (percentage above/below/at par) accordingly considering that no escalation and/or price adjustment will be allowed by the Department thereto under any circumstances.
- 34) Payment: The payment will be made as and when fund is available from the concerned source. No claim whatsoever for delay in payment, if any, will be entertained. No claim of contingency amount if added in the estimates will be entertained.
- 35) Successful bidders will be required to observe the following conditions strictly:
- a) Employees' Provident Fund and Miscellaneous Provisions Act, 1952 and Employees State Insurance Act, 1948 should be strictly adhered to wherever such Acts become applicable.
  - b) Minimum wages to the workers shall be paid according to the rates notified and/or revised by the State Government from time to time under the Minimum Wages Act, 1948 in respect of scheduled employments, within the specified time as per law. Payment of bonus, wherever applicable, has to be made.
  - c) Adequate safety and welfare measures must be provided as per the provisions of the building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act, 1996 read with West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.
  - d) All liabilities arising out of engagement of workers are duly met before submission of bills for payment.
- If there is any violation of any or all the relevant above criteria during execution of the job, it will render the concerned agencies ineligible for the work then and there or at any subsequent stage as may be found convenient.
- 36) No. price preference and other concession as per order no.1110F dated: 10/02/2006 will be allowed.
- 37) In respect of Security Deposit, Payments, etc. the conditions mentioned in the Form 2911 are superseded and will be guided according to the clauses mentioned in the NIEt documents.
- 38) Formalities: During execution if any approval from the competent authorities is required the same must be obtained by the Bidder/agency.
- 39) Eligible applicant should fulfill all the eligibility criteria. However, the tender inviting authority reserves the right to relax the eligibility criteria if felt necessary.
